Persatuan Hak Bapa Malaysia (Father's Rights Association of Malaysia) Membership Terms and Conditions

Effective February 5, 2021

1. Applicability.

This Membership Agreement ("Agreement") is between the Member, the applicant for membership ("Member"), and FRAM, an association with the registered address at Lot 2.01B. 2nd Floor, Wisma Equity, 150, Jalan Ampang, 50450 Kuala Lumpur, Malaysia. ("FRAM") (and collectively "Parties").

In applying for membership in FRAM, Member agrees to be subject to these Terms and Conditions and further warrants that FRAM may revoke Member's membership in FRAM at any time for Member's failure to abide by the Terms and Conditions. By submitting the application form, Member acknowledge and agree to be bound by these Terms and Conditions ("Agreement").

Members understands that the rights of membership, including the right to identify membership, begin only when member have been notified that member application for membership has been accepted, and only for as long as member are an active member of FRAM.

2. Term and Membership.

The term of this Agreement (the "Initial Term") commences on the date Member submits application page (the "Effective Date") and fully pays the required membership dues.

- Normal Member: Yearly, upon expiration of the Initial Term, this Agreement shall automatically renew for successive terms ("Renewal Terms") of equal length to the Initial Term, unless either Party provides written notice of nonrenewal., member understands member's FRAM membership will automatically continue and member authorizes FRAM (without notice to member, unless required by applicable law) to collect the then-applicable membership fee, which is subject to modification without notice, and any taxes, using any eligible payment method FRAM has on record for member. Have voting rights.
- Lifetime Member:Lifetime, no expiration unless expressly terminated by FRAM. Have voting rights.
- Honorary Member: A person who had been recognized for his ability to contribute to the association and elected by the FRAM committee. No voting rights.
- Teenage Member:Open to a person who is age below 18 years old. Their membership must be accompanied with an approval letter from either their father or mother or a guardian. No voting rights.

3. Termination.

Either Party, in its sole discretion, may terminate this Agreement at any time without cause, by providing at least fourteen (14) days' prior written notice to the other Party. Member may terminate his membership by notifying FRAM by contacting FRAMthrough registered post to the addressgiven above; or by email at persatuanhakbapamalaysia@gmail.com

4. No Refunds.

FRAM shall not be responsible for a refund of any fees, dues, course or certification fees or costs, expenses, and charges paid by Members in the event of termination of the Member's membership.

5. Member Benefits and Rights.

Members receive benefits associated with their membership as may be identified from time to time by FRAM.

6. Non-Authority of Members.

Members are not authorized to represent FRAM in any official capacity unless approved and such approval is stipulated in writing by FRAM. Any unauthorized representation may amount to termination of membership and any other recourse available to be exercised by FRAM against the said Member.

7. Confidential Information.

All non-public, confidential or proprietary information of FRAM("Confidential Information"), disclosed by FRAM to Member, whether disclosed orally or disclosed or accessed in written, electronic or other form or media, and whether or not marked, designated or otherwise identified as "confidential," shall not be disclosed or copied by Member without the prior written consent of the FRAM.

Confidential Information does not include information that is:

- in the public domain;
- known to Member at the time of disclosure;
- rightfully obtained by Member on a non-confidential basis from a third party;
- FRAM shall be entitled to injunctive relief for any violation of this Section.

8. Disclaimer of Warranties.

FRAM makes no warranty whatsoever with respect to any services or obligations arising under this agreement.

9. Limitation of Liability.

In no event shall FRAM be liable to member or to any third party for any consequential, incidental, indirect, exemplary, special or punitive damages whether arising out of breach of contract, tort (including negligence) or otherwise, regardless of whether such damages were foreseeable and whether or not FRAM has been advised of the possibility of such damages, and notwithstanding the failure of any agreed or other remedy of its essential purpose.

10. Termination.

In addition to any remedies that may be provided under this Agreement, FRAM may terminate this Agreement with immediate effect upon written notice to Member, if Member:

- fails to pay any amount when due under this Agreement [and such failure continues for days after Member's receipt of written notice of nonpayment];
- has not otherwise performed or complied with any of the terms of this Agreement, in whole or in part; oras otherwise provided in these Terms and Conditions;
- fails to comply with the constitution of the Organization or to act in a manner that would tarnish the good name of the Organization.

11. Waiver.

No waiver by FRAM of any of the provisions of this Agreement is effective unless explicitly set forth in writing and signed by FRAM. No failure to exercise, or delay in exercising, any rights, remedy, power or privilege arising from this Agreement operates or may be construed as a waiver thereof. No single or partial exercise of any right, remedy, power or privilege hereunder precludes any other or further exercise thereof or the exercise of any other right, remedy, power or privilege.

12. Assignment.

Member shall not assign any of its rights or delegate any of its obligations under this Agreement without the prior written consent of FRAM. Any purported assignment or delegation in violation of this Section is null and void. No assignment or delegation relieves Member of any of its obligations under this Agreement.

13. Relationship of the Parties.

Nothing contained in this Agreement shall be construed as creating any agency, partnership, joint venture or other form of joint enterprise, employment or fiduciary relationship between the parties, and neither party shall have authority to contract for or bind the other party in any manner whatsoever.

Any legal suit, action or proceeding arising out of or relating to this Agreement or in relation to FRAM and the Member shall be instituted in accordance to the jurisdiction of the courts in Malaysia and each party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action or proceeding.

16. Severability.

If any term or provision of this Agreement is invalid, illegal or unenforceable in any jurisdiction, such invalidity, illegality or unenforceability shall not affect any other term or provision of this Agreement.

17. Survival.

Provisions of these Terms, which by their nature should apply beyond their terms, will remain in force after any termination or expiration of this Agreement.

18. Amendment and Modification.

FRAM reserves the right to change this Agreement and/or its terms at any time. Any change to this Agreement and/or its terms shall be effective as of the date of posting to the website of FRAM or actual notice to Member, whichever is earlier.
